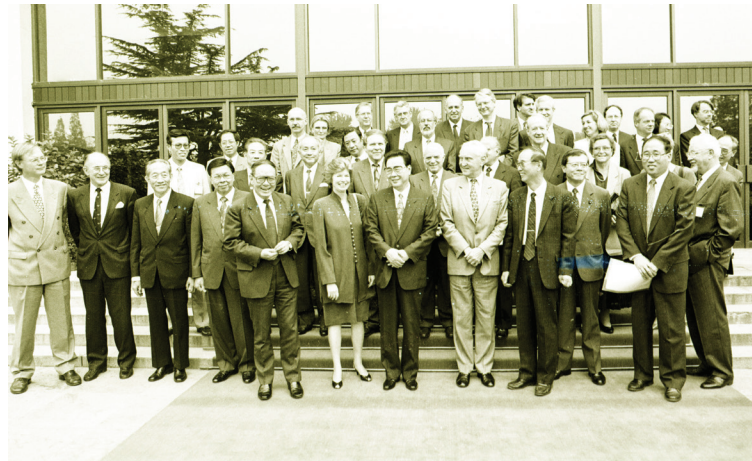
MAJOR DONOR AND FIRM SUPPORTER

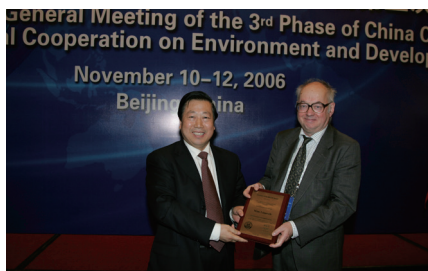

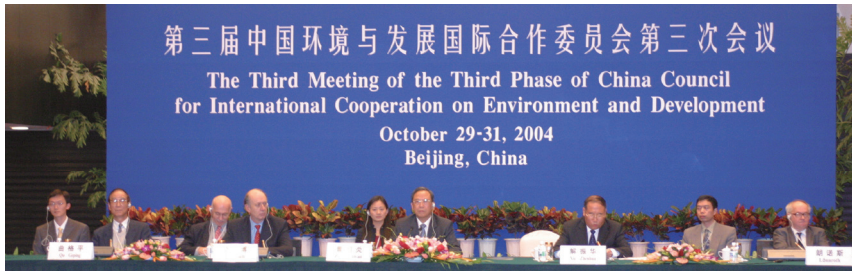
